Dear Santa Gertrudis Breeders,

The 2025 Cattleman's Opportunity Sale, hosted by the Mid-Coast Association, will be held **Saturday May 10, 2025 at 11 a.m.** at the **Washington County Fair Grounds in Brenham, TX**. This sale is open to consignments by all Mid-Coast members. If you are not a member, we invite you to join and bring your best to Brenham. Below are the sale rules and screening standards to assist you in selecting your lots. Please contact Sale Chairman Garrett Thomas (936) 714-4591 with any questions

***** ALL CATTLE CONSIGNED WILL BE SCREENED PRIOR TO SALE DATE.**

1. Pen lots of three head or less will be accepted.
2. All cattle must be registered Santa Gertrudis or Santa Gertrudis Star Five. (Consignors must be in good standings with SGBI).
3. Females must be between the ages of 6 months through 6 years (females must not be 7 years old date of sale).
4. Bulls 15 to 48 months of age are eligible ***** ALL BULLS MUST BE GAIN TESTED OR A PROVEN SHOW WINNER WITH GENETIC MERIT.**
5. Bulls must have a sheath score of 3 or less
6. Embryo, flushes, donor cows, bred recipient cows, and semen lots will be accepted.
7. Fertility – **A Licensed veterinarian must certify the following;**
 - Females over 26 months of age must calve by 36 months of age
 - Females with a calf at side that is 6 months of age or older must be safe in calf
 - Females with a calf at side that is 9 months of age or older must be safe in calf in at least the second trimester
 - Bulls, 18 months and older, must be fertility tested and confirmed a satisfactory breeder within 30 days of sale and Trich tested according to Texas Animal Health Commission rules

Other Considerations:

- Females with a calf under 6 months of age may sell open or exposed
- Any female 4 years old or older needs to have calving intervals included

8. Cattle must be sound, functional, and in good flesh. Any cattle falling under the “**Disqualification**” section of the SGBI “Standards of Excellence” will not be allowed to sell.
9. Cattle must have a health certification allowing interstate shipment and showing fertility results (if applicable), issued within 30 days of sale date. **Check with your veterinarian for any additional health requirements such as Brucellosis testing of cows over 18 months of age TB testing etc.**
10. **Photography/Videography-** Cattle are required to be both pictured & videoed. Consignors are responsible for all photography/videography that is required. Imaging due by April 5th. Some photographers working with the Mid-Coast Association are:

Any animal not meeting these requirements will be automatically removed from the sale offering.
